ORDINANCE OF THE TOWNSHIP OF LAKEWOOD, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING THE CONVEYANCE AND EXECUTION OF A DEED OF A FEE SIMPLE INTEREST TO THE COUNTY OF OCEAN FOR BLOCK 961.02 LOT 4 AND BLOCK 961.02 LOT 3

- **WHEREAS**, the Township of Lakewood is the owner of Block 961.02 Lot 4 and Block 961.02 Lot 3, fronting on portions of Pine Street, Vine Street and Cedar Bridge Avenue in the westernmost portion of the DA-1 (Cedarbridge Redevelopment) Zone not subject to the Option previously granted to Cedarbridge Redevelopment; and
- WHEREAS, this property is comprised of approximately 140 acres of freshwater wetlands and transition buffer, and is encumbered by conservation easements, specifically a Grant of Conservation Restriction for Forest and Riparian Zone Preservation Areas to the New Jersey State Department of Environmental Protection recorded at OR Book 16963 Page 1729 in the Ocean County Clerk's Office on December 8, 2017; and
- **WHEREAS**, said Grant of Conservation Restriction to the D.E.P. permits the transfer of same, provided the restrictions are incorporated into the transfer documents; and
- **WHEREAS**, Ocean County has reviewed a proposed acquisition of this property and has requested the sale thereof to the county for a purchase price of \$1,030,000.00; and
- **WHEREAS**, pursuant to N.J.S.A. 40A:12-13(b)(1) and 40A:12-13.4, the Township Committee may, by ordinance, sell or transfer any real property, capital improvements or personal property not needed for its public use at a private sale to any political subdivision, agency, department, commission, board, or body corporate and politic; and
- **WHEREAS**, the Township is satisfied that the granting by way of a deed to Ocean County is in the best interest of the residents of Lakewood Township.
- **NOW, THEREFORE, BE IT ORDAINED** by the Township Committee of the Township of Lakewood, County of Ocean and State of New Jersey as follows:
- **SECTION 1**. The Mayor or Deputy Mayor is authorized to execute and the Township Clerk to attest to a Contract of Sale, Deed and other related documents transferring title to Block 961.02 Lot 4 and Block 961.02 Lot 3 for a consideration of \$1,030,000.00 (with all applicable restrictions as set forth in the Grant of Conservation Restriction to the D.E.P. as set forth above and as set forth in said instrument) to the County of Ocean in a form and substance as approved by the Township Attorney.
- **SECTION 2.** That this ordinance repeals any inconsistent ordinance or ordinances or part or parts thereof.
- **SECTION 3**. This ordinance shall take effect immediately upon its final passage and publication as required by law.
