SUMMARY

The following Ordinance of the Township of Lakewood authorizes the Township to vacate all of the right, title and interest of and to the public in a portion of Halsey Street, from Clyde Avenue eastward to its terminus, as further outlined by description contained in the Ordinance, which portion of Halsey Street remains unimproved, and is not needed for public road purposes. The vacation of the subject portion of Halsey Street has been requested by the adjoining property owners as part of Planning Board approval for an addition to the Meon Hatorah Rabbinical College and Tashbar School. It has been determined that the vacation of this portion of Halsey Street lends itself to higher and better use than for public road purposes, and that it is in the best interests of the general public and the Township of Lakewood that the right and interest in and to same shall as a public right of way be vacated, released and extinguished.

SUMMARY

The following Ordinance of the Township of Lakewood authorizes the Township to vacate all of the right, title and interest of and to the public in a portion of East Kennedy Boulevard, between North Apple Street and the New Jersey Southern Railroad Right-of-Way, as further outlined by description contained in the Ordinance, which portion of East Kennedy Boulevard is a paper Street and remains unimproved. This portion of East Kennedy Boulevard to be vacated is bordered to the north by Lots 12.01 through 12.06 in Block 172, which are the subject of a development application to develop the property for residential uses, and provides for the portion of East Kennedy Boulevard between North Apple Street and the New Jersey Southern Railroad Right-of-Way to be improved as a fifty (50) foot wide public street with a cul-de-sac.
