On Roll Call – Affirmative: Mr. Miller, Senator Singer, Mr. Coles, Deputy Mayor Lichtenstein and Mayor Cunliffe.

PRESENTATIONS: None

Mayor Cunliffe asked Mr. Lines for an update with regard to the Route 9-James Street-Pine Street improvement project.

Mr. Lines advised he sent a letter to the NJ DOT representatives outlining the comments and suggestions offered by the Township Committee.

As to the Fairways traffic signal, Mr. Lines advised there was a problem with the design and construction of that traffic signal. They are going to temporarily realign the head of the signal, and then install a ten foot extension arm.

As to the topics brought up by Mrs. Eisenberg, Mr. Mack advised they have prepared an extensive report on the Morris Avenue property, including a list of summons, two of which are on the subject property, one for overcrowding.

As to the properties in Coventry Square, Mr. Yhost advised they have made arrests with regard to the burglary problems.

Mayor Cunliffe asked that the properties be checked for overcrowding conditions.

As to the feasibility of a left turn lane on Route 9 and Central Avenue, Mr. Lines advised there presently is a left turn lane, in both directions, on Route 9 at Central Avenue.

Mr. Christopher advised he wanted a left turn arrow from Route 9 going North, turning left into Central Avenue.

Comments from the public will be heard for a limit of one (1) hour. Each speaker will have four (4) minutes and shall be limited to one time at the Podium.

James Waters, 1275 Old County Line Road – Commented with regard to overcrowding conditions in some homes and apartments in town. He wants to correct the problem but hopes that it does not create a homelessness problem.

Barbara Eisenberg, Morris Avenue – Thanked the Township for working on the problems in her neighborhood. Complained about people that do not dig their cars out of the snow for a long period of time. Complained also about the car that was in the accident and has not been moved in a few months.

Mayor Cunliffe asked the Clerk's Office to review what Ordinances there are regarding snow removal. He would like the Committee to consider some type of snow emergency Ordinance for Lakewood. He feels they need to get the cooperation of the residents.

Mr. Franklin advised that a big cost to the snow removal in Lakewood is that people do not remove their cars from the street. He also suggested that an Ordinance be adopted to help alleviate the problem.

Senator Singer suggested they consider hiring private contractors to help with the snow removal during heaving snowfalls.

Jim Cosaro, 28 Autumn Drive – Commented with regard to the sale of Township owned land for private schools.

Ted O'Keefe, Golden Seasons Drive – Commented with regard to the sale of Township owned land for private schools, and will busing and sidewalks be required for these schools.

Larry Simons, Schoolhouse Court – Commented with regard to the conveyance of Township owned land.

Bernard Williams, Clifton Avenue – Thanked the Committee members for attending the Martin Luther King breakfast.

Laura Quinones – Commented on the overcrowding issue. Advised she is about to become homeless, because she can not afford to pay the rent on her home.

Mayor Cunliffe asked that she provide her contact information to the Clerk so they can contact the social service agencies to see if they can find assistance for her.

Noreen Gill, 192 Coventry Drive – Commented on the homeless issue, and the price of rents in Lakewood.

Chris Abrams, Coral Avenue – Offered suggestions with regard to the website. Requested that the Township consider the vacation of the portion of Oak Street which is part of the buffer promised to them with the affordable housing plan. Two cul-de-sacs can be put opposite each other in the vacated section, and this would do much to boost their confidence in the Committee and to assure that they maintain the comfort they currently enjoy. They also asked that any left over land be set aside for open space to accommodate the numerous children that live in the area.

Don Albanese, 4 Gardenways Court – Commented on uncontrolled population growth.

Akiva Gunter, 1502 Twin Oaks Drive – Spoke in favor of the sale of Township owned property for private schools.

David Drukaroff, 1433 Laurelwood Avenue - Commented on the public and private school systems.

Alan Krupnick – Owns land within the proposed school sites. He is not opposed to the concept of sale of Township owned land for educational purposes, but feels that the Ordinances as presented are detrimental to private property owners with respect to the proposed street vacations.

Alice Kelsey, 295 Malvern Court – Asked about the relocation of tenants. Spoke in favor of the proposed affordable housing units.

Seeing no one else wishing to be heard, Mayor Cunliffe closed the meeting to the public.

At this time, Mayor Cunliffe addressed a matter of correspondence with regard to NJ Hand. They wanted to know if the vacation of the streets as they are proposed for the school sale, would that land-lock the affordable housing track or are there other paper streets to be able to get into that area.

Mr. Lines advised there are numerous other paper streets to be able to get into the NJ Hand parcel. The paper streets they are vacating in Parcels 1 through 4, the existing paper right-of-ways are maintained around that entire parcel. They will not be land-locked.

Mayor Cunliffe explained that usually when streets are vacated, there are two private owners, and in that instance the paper street is divided between the owners. These are being divided for a different reason. They are being divided for consolidation, and to also to carve out as close as possible, equal parcels of land. So it is not exactly the same type of vacation. The Township is doing this to consolidate land and to enable the metes and bounds to be written in a more clear fashion.

Mr. Secare explained it is more of an engineering issue. The Engineer prepared the metes and bounds descriptions.

Mr. Lines explained in this case, it was decided to keep property lines to one side.

Mr. Edwards stated that in each case, the way they have been drawn up, is the road is still being split down the middle. The Township happens to be the property owner on each side of the area to be vacated. All the parcels that are privately owned have alternative access to other streets.

Sheldon Landman, representing NJ Hand – Asked if Funston Avenue is still going to be available through to Oak Street.

Mr. Lines answered yes.

As to the 6.43 acre parcel, it just ended up that this parcel includes two very large blocks that the Township owns almost all of the land.
