SUMMARY

Pursuant to N.J.S.A. 40:67-1(b), it is the intent of the following Ordinance for the Township of Lakewood to vacate previously accepted dedicated property for open space. Pursuant to Ordinance No. 2014-74, the Township of Lakewood previously accepted the dedication of Block 430, Lot 16 as open space area. The Township now wishes to vacate this previously accepted parcel's designation as "Open Space" for Block 430, Lot 16, thereby permitting the Township as the property owner to finalize the sale thereof free of the open space designation. SUMMARY

The following Ordinance amends Chapter II of the Code of the Township of Lakewood, entitled "Administration", Article XI entitled "Police Department", Section 2-20.9 entitled "Off-Duty Assignments of Police Officers", more specifically Section 2-20.9, Paragraph 6, to reflect that the fee for a Township Vehicle shall be one hundred (\$100.00) dollars per vehicle per man. This fee is not applicable to non-profit organization(s) and may be waived for other organizations(s) at the discretion of the Chief of Police or his designee. This Ordinance further amends Paragraph 6 to reflect that the fees for off-duty assignments for schools, houses of worship and other nonprofit entities shall be a total of forty-seven (\$47.00) dollars per hour. Forty (\$40.00) dollars for each hour shall be paid to the officer assigned and seven (\$7.00) dollars per hour shall be paid to the Township for administrative and management costs.
