The Urban Enterprise Zone Assistance Fund is to be used for the purpose of assisting qualified municipalities in which enterprise zones are designated in undertaking public improvements and in upgrading eligible municipal services in designated enterprise zones.

The governing body of the *Township of Lakewood* designated in *1994* as a qualified municipality in the *County of Ocean* which an enterprise zone is designated, and created by the participating municipality for said zone have, by resolution jointly adopted after public hearing, proposed to undertake the following project which is a public improvement of the enterprise zone or will increase eligible municipal services in the enterprise zone. The monies therefore are now deposited in the local Enterprise Zone Assistance Fund and are administered by the Lakewood Development Corporation.

"Any individual, including an individual who is not directly employed by a municipality, with the authority to administer, allocate, or approve the use of Zone Assistance Funds is subject to the "Local Government Ethics Law" P.L. 1991, c.29 (C.40A:9-22.1 et. seq.)".

Commerce regulation 12A:2A-3.1 provides for the payment of prevailing wage in connection with certain construction contracts funded in whole or in part with zone assistance funds. Any zone assistance funds approved for use in accordance with this proposal will not be utilized in a manner that would violate said provision.

I. PROJECT DESCRIPTION

Objective: to alleviate garbage congestion in the downtown corridor and eliminate green and yellow garbage receptacles to improve aesthetics and the downtown shopping experience for UEZ businesses and their customers. This endeavor will lead to improved access and foot traffic to the downtown UEZ corridor and hence promote the conditions for increased economic and employment activities.

The current situation in the UEZ downtown corridor is significantly less than ideal. With garbage, cardboard boxes and other obstacles piling up on the street and obstructing store fronts, it presents dangerous conditions and an impediment to the efficient ingress and egress of UEZ businesses. Lakewood township has conducted research, using townships in Virginia as a model, and has found that Virginia has successfully utilized mechanical compactors to vastly improve their business districts. These compactors are strategically positioned in the back of the businesses to facilitate the disposal of the aforementioned items

The \$250,000.00 being requested will be used to purchase 4 compactor units and all the accoutrements associated with completing the project.

- Each compactor has 35 Cubit Yards capacity
- Total cost per unit including electrical, fencing etc. \$62,000
- Compactor Site Locations:
 - o 1st St. & Rt. 9 parking lot
 - o 225 4th St. behind Gelbstein's bakery
 - o 240 3rd St. Municipal parking lot corner
 - 242 2nd St. narrow alley way lot

This project will enable the township with in the UEZ areas to eliminate the need to drive garbage trucks down the main business areas hence alleviating major vehicle traffic congestion for a more efficient traffic flow and allow for an increase in economic activity.






