

**ORDINANCE OF THE TOWNSHIP OF LAKEWOOD, COUNTY OF OCEAN,
STATE OF NEW JERSEY, AMENDING AND SUPPLEMENTING AN
ORDINANCE ENTITLED "AN ORDINANCE ESTABLISHING THE ANNUAL
MINIMUM AND MAXIMUM SALARY RANGES FOR THE OFFICES AND
POSITIONS OF PERSONS EMPLOYED BY THE TOWNSHIP OF LAKEWOOD
IN THE COUNTY OF OCEAN AND STATE OF NEW JERSEY AND
PROVIDING FOR AN EFFECTIVE DATE 20 DAYS AFTER PUBLICATION
AFTER FINAL ADOPTION**

BE IT ORDAINED, by the Township Committee of the Township of Lakewood, County of Ocean, State of New Jersey, that a certain Ordinance adopted by the Township Committee of the Township of Lakewood on April 26, 1962 entitled "An Ordinance Establishing the Annual Minimum and Maximum Salary Ranges for the Offices and Positions of Persons Employed by the Township of Lakewood in the County of Ocean and State of New Jersey", as amended, be and hereby is further amended and supplemented in the following part only.
