

**ORDINANCE OF THE TOWNSHIP OF LAKEWOOD,
COUNTY OF OCEAN, STATE OF NEW JERSEY,
AMENDING AND SUPPLEMENTING CHAPTER XI
(Traffic) OF THE REVISED GENERAL ORDINANCES OF
THE TOWNSHIP OF LAKEWOOD, SPECIFICALLY
SECTION 11-35 (HANDICAPPED PARKING).**

BE IT ORDAINED by the Township Committee of the Township of Lakewood, County of Ocean, State of New Jersey, as follows:

SECTION 1. That Chapter XI of the Revised General Ordinances of the Township of Lakewood entitled "Traffic", Section 11-35 entitled "Handicapped Parking", be and hereby is amended and supplemented as follows:

11-35 HANDICAPPED PARKING.

<i>Street</i>	<i>No. of Spaces</i>	<i>Location</i>
Long Beach Avenue	2	<u>Northeast side of the intersection of Long Beach Avenue and Joe Parker Road starting at a point 103' feet from the prolongation line of the intersection of Long Beach Avenue and Joe Parker Road continuing a distance of 44 feet easterly thereof.</u>

SECTION 2. All ordinances or parts of ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency.

SECTION 3. If any section, subsection, paragraph, sentence or any part of this Ordinance is adjudged unconstitutional or invalid, such judgment shall not affect, impair or invalidate the remainder of this Ordinance not directly involved in the controversy in which such judgment shall have been rendered.

SECTION 4. This Ordinance shall take effect immediately upon final passage and publication as required by law.
