

NOTICE OF ONLINE PUBLIC AUCTION FOR SALE OF SURPLUS PERSONAL PROPERTY NO LONGER NEEDED BY THE TOWNSHIP OF LAKEWOOD, COUNTY OF OCEAN, STATE OF NEW JERSEY

The Township of Lakewood will conduct an online public auction sale of its surplus property through GovDeals. The auction will be held pursuant to N.J.S.A. 40A:11-36 and New Jersey's E-Procurement Pilot Program, 2001, P.L. 2001,C.30 on GovDeals' online auction site www.govdeals.com/lakewoodnj

The auction will begin on April 12, 2021 at 1:00 am and end April 18, 2021 at 11:59 pm. Inspection of items for sale will be April 12, 2021 from 10:00 am to 1:00 pm at the DPW Facility, 1 America Avenue Lakewood, NJ 08701. Township employees escorting potential buyers are not authorized to answer any questions pertaining to any vehicle or piece of equipment offered for auction.

Bidders for this auction must electronically register at the website and, by taking part in the bidding process, are acknowledging that they fully understood the terms and conditions outlined on the site and agree to be bound thereby. The payment terms of the sale are posted on the website.

All sales will be made to the highest bidder and shall be final. All items are sold in an "as is, where is" condition, free from any guarantee or warranty. Buyer understands that additional damage may have been made to the item since the posting of the information on the auction webpage.

Removal shall take place between the hours of 10:00 am and 1:00 pm Monday through Friday April 19, 2021 through April 27, 2021. Buyer is responsible for all aspects of the removal of the purchased items, including loading and transportation, from Township property. Buyer must produce proof of purchase and payment to the Township employee authorized to release the item. Vehicle titles and keys will not be released without this documentation. All motorized vehicles and/or equipment must be removed, not driven, from the DPW complex and will not be allowed to reenter.

After April 27, 2021, there will be a \$15.00 per day storage fee for any item not removed. After May 7, 2021, the property ownership will revert back to the Township and payment thereof will be kept by the Township. Partial days are considered full days.

The Township reserves the right to accept or reject any or all bids.
