

ORDINANCE OF THE TOWNSHIP OF LAKEWOOD, COUNTY OF OCEAN, STATE OF NEW JERSEY, AMENDING AND SUPPLEMENTING CHAPTER III OF THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF LAKEWOOD, 1999, ENTITLED "POLICE REGULATIONS" BY THE ADDITION OF A NEW SECTION 3-30 ENTITLED "CODE BLUE WARMING CENTER"

BE IT ORDAINED by the Township Committee of the Township of Lakewood, County of Ocean, State of New Jersey, that:

SECTION 1. Chapter III of the Revised General Ordinances of the Township of Lakewood, 1999, entitled "Police Regulations" shall be amended and supplemented by the addition of a new Section 3-30 entitled "Code Blue Warming Center", as follows:

3-30 CODE BLUE WARMING CENTER

- A. The Code Blue Warming Center for the Township of Lakewood is established to protect the health, safety and welfare of the residents of Lakewood during certain weather conditions.
- B. The purpose of this Ordinance is to establish the Lakewood Community Center as the Code Blue Warming Center of the Township of Lakewood and to authorize the Chief of Police and/or his/her designee to declare a Code Blue event.
- C. The Chief of Police and/or his/her designee is hereby authorized to declare a Code Blue Event for the Township's Code Blue Warming Center, when the weather in the municipality is 35 degrees Fahrenheit or lower, regardless of precipitation conditions.

SECTION 2. All ordinances or parts of ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency.

SECTION 3. This ordinance shall take effect twenty (20) days after its final passage by the Township Committee and approval by the Mayor where such approval is required by law.


