

**ORDINANCE OF THE TOWNSHIP OF LAKEWOOD, COUNTY OF OCEAN,
STATE OF NEW JERSEY, AMENDING AND SUPPLEMENTING CHAPTER II
ENTITLED "ADMINISTRATION" BY SPECIFICALLY CREATING SECTION 2-
76.9 TO ESTABLISH THE LAKEWOOD SHUTTLE AND FEE SCHEDULE
FOR THE SAME**

Purpose. The purpose and intent of this Ordinance is to establish a motor vehicle transportation system and fee schedule within the Township of Lakewood for short distance transportation within the Township.

SECTION 76.9. That Chapter II entitled "Administration" of the revised general ordinances of the Township of Lakewood, to create a new section 2-76.9 to be named "Lakewood Shuttle Bus Creation and Fees":

SECTION 1.

1. There is hereby created within the Township of Lakewood a short distance transportation system known as the Lakewood Shuttle.
2. The Lakewood Shuttle shall operate wholly within the Township of Lakewood.
3. The buses for the Lakewood Shuttle shall be operated and maintained by the Department of Public Works.
4. The fare for each ride shall be \$1.00 per person for one way.

SECTION 2. All ordinances or parts of ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency.

SECTION 3. If any section, subsection, paragraph, sentence or any part of this Ordinance is adjudged unconstitutional or invalid, such judgment shall not affect, impair or invalidate the remainder of this Ordinance not directly involved in the controversy in which such judgment shall have been rendered.

SECTION 4. This Ordinance shall take effect immediately upon final passage and publication as required by law.

NOTICE

PUBLIC NOTICE is hereby given that the foregoing Ordinance was introduced at a meeting of the Township Committee of the Township of Lakewood, in the County of Ocean and State of New Jersey on the **16th day of August, 2018**, and was then read for the first time. The said Ordinance will be further considered for final passage by the Township Committee in the Town Hall at 7:30 p.m. on **September 6, 2018**. At such time and place or any time or place to which said meeting may be adjourned, all persons interested will be given an opportunity to be heard concerning said ordinance.
