

**ORDINANCE OF THE TOWNSHIP OF LAKEWOOD, COUNTY OF OCEAN, STATE OF NEW JERSEY, AMENDING AND SUPPLEMENTING CHAPTER XI ENTITLED "TRAFFIC" OF THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF LAKEWOOD, SPECIFICALLY SECTION 11-14 ENTITLED "PARKING PROHIBITED DURING CERTAIN HOURS ON CERTAIN STREETS"**

**BE IT ORDAINED** by the Township Committee of the Township of Lakewood, County of Ocean, State of New Jersey, as follows:

**SECTION 1.** That Chapter XI entitled "Traffic" of the revised general ordinances of the Township of Lakewood, specifically Section 11-14 entitled "Parking Prohibited During Certain Hours On Certain Streets" be and hereby is amended and supplemented as follows:

**11-14 PARKING PROHIBITED DURING CERTAIN HOURS ON CERTAIN STREETS**

- 1. No person shall park a vehicle between the hours specified on any day upon any of the streets or parts of streets described.

**11-14 PARKING PROHIBITED DURING CERTAIN HOURS ON CERTAIN STREETS**

Manetta Avenue	East	7am to 2pm Every Tuesday	Beginning at a point of the curblines of Manetta Avenue and Carriage Court and extending for a distance of 75" south

**SECTION 2.** All ordinances or parts of ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency.

**SECTION 3.** If any section, subsection, paragraph, sentence or any part of this Ordinance is adjudged unconstitutional or invalid, such judgment shall not affect, impair or invalidate the remainder of this Ordinance not directly involved in the controversy in which such judgment shall have been rendered.

**SECTION 4.** This Ordinance shall take effect immediately upon final passage and publication as required by law.
