Pursuant to N.J.S.A. 52:34-6.2(b)(3), notice is hereby given that the Board of Fire Commissioners of Fire District No. 1, Township of Lakewood, County of Ocean, intends to utilize a National Cooperative Purchasing Agreement with Sourcewell cooperative for the procurement of rescue equipment. The Board is permitted, pursuant to the above mentioned statutory authority, to utilize a national cooperative as an alternate procurement method.
