RESOLUTION

A Resolution of the Lakewood Industrial Commission Authorizing the entering into an Agreement with the State of New Jersey Department of Transportation for award of a Grant titled:

Grant No. 6915323 – Helipad Design Update, Bidding, Construction

WHEREAS, the Lakewood Industrial Commission, created by passage of N. J. S. A. 40:55B-1, et seq., and as amended and supplemented by Lakewood Township Revised Ordinances 2-38, et seq. entitled INDUSTRIAL COMMISSION, is charged with fostering economic and industrial development within the Township of Lakewood; and

WHEREAS, the Industrial Commission of the Township of Lakewood (hereinafter cited as "Lakewood Industrial Commission") was transferred ownership by the Township of Lakewood of the lands and assets known as Lakewood Airport; and

WHEREAS, it is the desire of the Lakewood Industrial Commission to implement the *Helipad Design Update*, *Bidding and Construction* project at Lakewood Airport, 1900 Cedar Bridge Avenue, Lakewood, Ocean County, New Jersey; and

WHEREAS, the total cost of the *Helipad Design Update*, *Bidding and Construction* project is estimated to be \$753,478.82; and

WHEREAS, the New Jersey Department of Transportation has offered to provide the Lakewood Industrial Commission a grant to cover ninety percent (90%) of the grant eligible costs of this project for an amount not to exceed \$678,130.00; and

WHEREAS, the required local share of ten percent (10%) of grant eligible costs, plus all ineligible costs, would be required from the Industrial Commission of the Township of Lakewood in an amount of up to \$75,350.00.

WHEREAS, application was authorized to be made to the State of New Jersey for this project dated October 17, 2019, and updated May 4, 2020; and

NOW, THEREFORE BE IT RESOLVED by the Lakewood Industrial Commission that the Lakewood Industrial Commission is authorized to manage a formal grant application to the New Jersey Department of Transportation for the receipt of grant funds for the *Helipad Design Update*, *Bidding and Construction* project at Lakewood Airport in Lakewood, NJ.

BE IT FURTHER RESOLVED THAT:

1. The Executive Director/Airport Manager is hereby authorized to submit formal grant applications to the New Jersey Department of Transportation.

- 2. The Executive Director/Airport Manager and other designated signatories of the Lakewood Industrial Commission are hereby authorized to execute all documents and agreements required by the New Jersey Department of Transportation for receipt and management of grant funds in an amount of up to \$678,130.00 made available for this purpose.
- 3. Copies of this resolution shall be made available to the Township Clerk of the Township of Lakewood and the New Jersey Department of Transportation, Division of Aeronautics.
