I am a resident of the State of New Jersey. I am against the ritual slaughter of chickens known as Kapparot, as are many others including residents of Lakewood and the surrounding area.

Given that money/coins could be used in place of chickens, then donated to charity, I would ask that Lakewood encourage this be done instead of the slaughter of innocent sentient beings. Animal cruelty (i.e. chickens packed in small crates for days with no food/water, swung about injuring their feet and breaking their wings, then violently killed with a knife) is not compassionate. Chickens are intelligent sentient beings who are able to experience fear and pain.

Further, the chickens are to be sacrificed according to the *law of shechita*, but many, if not most, are being thrown away and not given to a charity for consumption at the pre-Yom Kippur meal... coins may be a better option.

The Kapparot ritual of slaughtering chickens needs to be eradicated especially given the fact that not only are coins used by many, also, many Rabbis (in the area) recommend coins be used in place of the ritual slaughtering of chickens especially in this day and age of pandemics and zoonotic diseases but also as a more compassionate approach to such a holy holiday.

My name is Lisa Tarzia. I reside at 22 Spruce Lane in Montgomery. Until recently I was a resident of Ocean County. Today I would like to make a statement regarding the observation of Kaporos which took place in Lakewood last year, 2020.

During the observation of Kaporos in Lakewood last year, it was noted that one participating Rabbi made obvious improvements for the conditions in which the chickens were kept. These improvements included providing shelter, food, water, and a free range area for the chickens to roam free, rather than containment in overcrowded battery cages. These improved conditions appeared to adhere to NJ Title 4 Statutes for Animal Welfare. However, this Rabbi and those joining him, continued the practice of holding the chickens by unnaturally forcing their wings back behind their bodies, which is known to cause serious, painful bruising and broken wings. Licensed veterinarians who have evaluated chickens that have been injured during Kaporos rituals have verified that handling chickens in this manner is painful and inhumane. This would be a violation of NJ Title 4 Statutes for Animal Welfare. This Rabbi does not appear to be slaughtering the chickens on site. It is not known if the chickens are being slaughtered off site, sold or distributed to the public.

One participating Rabbi utilized baskets to hold the chickens during the ritual, rather than forcing the chickens' wings back behind their bodies. This is the more humane method to handle the chickens. This Rabbi appeared to be slaughtering the chickens on site. It is believed that these slaughtered chickens are being donated to a soup kitchen fun by the Rabbi's family, however, the location of the soup kitchen is not known. It is not known whether a permit is needed or was obtained, in order to distribute slaughtered chickens, if the Rabbi is not a licensed butcher, slaughterhouse, or wet market in the state, which must follow NJ biohazard safety protocols in the handling, transportation or distribution of poultry. It is not known if safety protocols were observed when the chickens were slaughtered, packaged, transported or distributed to the soup kitchen to ensure the safety and welfare of the public consuming the poultry.

Although some improvements were made in the treatment of the chickens, I still implore those participating in the observance of Kaporos to please stop the use of chickens, and please use coins instead, as many of the Jewish faith have begun to do. This would be a humane, loving way to observe Kaporos with children, family and friends, and safe for the public. Thank you.
