The bid must be delivered to the Lakewood Fire District No. 1 Administrative Building, 733 Cedar Bridge Avenue, Lakewood, New Jersey, at 10:00 a.m. on June 24, 2021. If mailed, all bids must be mailed by Certified Mail to the Board of Fire Commissioners of Fire District No. 1, Township of Lakewood, 733 Cedar Bridge Avenue, Lakewood, New Jersey 08701, and received on or before the above set forth time and date.

No bid will be considered unless in writing on the form furnished.

Bids may not be faxed, transmitted over the telephone or emailed. The Board of Fire Commissioners of Fire District No. 1, Township of Lakewood, assumes no responsibility for delays in any form of carrier, mail or delivery service causing the bid to be received untimely.

Bidders must submit proof with the bid of registration with the New Jersey Department of Treasury, Division of Revenue, by submitting a copy of bidder's Business Registration Certificate.

Pursuant to N.J.S.A. 10:5-31, bidders are required to comply with the requirements of P.L. 1975, c.127, N.J.A.C. 17:27.

The Board of Fire Commissioners of Fire District No. 1, Township of Lakewood, reserves the right to reject any or all bids not deemed to be in the best interest of the Fire District.
