SUMMARY

The Lakewood Township Committee has determined that it is advisable and necessary to increase its CY 2016 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens. The following Ordinance provides that in the CY 2016 Budget year, the final appropriations of the Township of Lakewood shall, in accordance with this Ordinance and N.J.S.A. 40A:4-45.14, be increased by 3.5% over the previous year's final appropriations, amounting to \$2,170,301, and that the CY 2016 Municipal Budget for the Township of Lakewood be approved and adopted in accordance with this Ordinance. This Ordinance further provides that any amount authorized herein that is not appropriated as part of the final Budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

SUMMARY

The purpose of the within Ordinance is to vacate all of the right, title and interest of and to the public and the rights of the Township to public property, in and to a drainage easement, shade tree easement, and two (2) sight triangle easements, located on a portion of Block 769, Lots 19.10, 19.11, 19.12 and 19.13, as further outlined by description contained in this Ordinance. The Township Committee has been requested to vacate the right, title and interest of the Township to this drainage easement, shade tree easement, and two (2) sight triangle easements, inasmuch as the subject easements have never been utilized as easements due to the prior vacation of a portion of Melville Avenue, and is part of the parcel that has been approved for subdivision pursuant to a Resolution of the Lakewood Township Planning Board. The owners of the aforementioned properties have requested that the subject easements be released, extinguished, and vacated and have tendered the appropriate payment for this request. The easements being vacated shall revert to and remain part of Block 769, Lots 19.10, 19.11, 19.12 and 19.13. This Ordinance further authorizes the Mayor and Township Clerk to execute a Quitclaim Deed releasing, extinguishing and vacating the subject easements on the properties. SUMMARY

The following Ordinance amends Chapter 3 of the Revised General Ordinances of the Township of Lakewood, entitled "Police Regulations", by the addition of a new Section 3-29 entitled "Prohibiting the Possession of Weapons at First Energy Park", to ensure the health, safety and welfare of those persons attending events at First Energy Park, and to provide for the definitions of the prohibited weapons. It shall be illegal for anyone to possess a weapon at First Energy Park or the surrounding parking lots contiguous to or adjacent to First Energy Park. This prohibition shall not apply to Lakewood Township Police Officers assigned to duty at First Energy Park. This Ordinance further outlines certain exceptions to the regulations of this Ordinance, and provides for the penalties to be invoked upon any person found guilty of violating the provisions of this Ordinance.
