PRESENTATIONS

Ally Morris - Employee of the Month

Mayor Miller presented Ally Morris with the Employee of the Month Award for May, 2014.

As there were many residents present at this meeting with regard to a certain matter, Committeeman Langert requested that the following Ordinance be acted upon at this time:

Mayor Miller opened the meeting to the public. Seeing no one wishing to be heard, the hearing on this Ordinance was closed to the public.

Committeeman Langert thanked everyone on the Committee during this process.

Everyone participated in this matter, and everyone deserves credit. The Committee cares about all of Lakewood, and everyone who lives in Lakewood.

Mayor Miller advised that Deputy Mayor Akerman had a lot of input in this matter in dealing with the neighborhoods, in making sure it was worked out on all sides.

QUALITY OF LIFE

Mayor Miller reviewed quality of life items from a previous meeting.

With regard to Mayor Miller's request that Public Works continue filling pot holes throughout the town, Mr. Arecchi responded that this matter is ongoing, and is scheduled again this week; they have started doing hot patch as well as cold patch repairs.

With regard to the letter received from senior communities requesting that a Police Officer be designated to be assigned to the active adult communities, this matter will be brought back for discussion at the next meeting.

Comments from Committee Members on Quality of Life Items –

Committeeman Lichtenstein requested that the Engineering Department look at the traffic light at Fourteenth Street and Forest Avenue; they have received e-mails that the light is twisting in the wind, pointing the lights in the wrong direction. He asked that this light be repaired.

Committeeman Lichtenstein commented with regard to Presidential Estates. He has received a report as to what the developer has to do, or whoever is going to be doing the work to correct the drainage problems and to finish the bonded items. He asked if they have received any response from the Homeowner's Association.

Mr. Staiger responded that he has spoken to a few home owners, but not the Association. The homeowners appear to be satisfied with what is going to be done and they feel it will resolve the issues.

Committeeman Lichtenstein requested that Mr. Staiger schedule a meeting with the Homeowner's Association, and let him know when the meeting will be held.

Committeeman Lichtenstein also advised that two roads in his neighborhood that he travels need some attention, in the line of cold and hot patch repairs: Cedar Row, from County Line Road to Forest Avenue; and Oakwood Avenue, from County Line Road to Forest Avenue.

Committeeman Langert commented with regard to the timing signal on Route 9 and Central Avenue, as well as the traffic signal at Route 9 and James Street. They have had numerous correspondences with the State. He asked if they can get someone from the State to observe the traffic, and do something about the timing change.

Mr. Staiger responded they can reach out to the State. It is hard to get answers from them with regard to the lights, or they are not seeing the problem and coming at different times than when there appears to be problems.

Mayor Miller advised they can contact the Senator to intercede with the State to request to send someone from the appropriate department to come out at the requested time.

Committeeman Lichtenstein requested that a four-way stop be considered for the intersection of Kennedy Boulevard and Somerset Avenue. And also, once that decision is made, he asked Public Works to dress-up the intersection, paint the curbs and crosswalks, and install the stop signs, if the Police Department decides that a four-way stop is warranted.

Committeeman Lichtenstein also advised there is a vacant lot there where the shrubs are blocking the present stop sign. He asked that the bushes be trimmed back.

Comments from the public will be heard for a limit of one (1) hour. Each speaker will have four (4) minutes and shall be limited to one time at the podium.

Mayor Miller opened the meeting to the public.

Bill Hobday – Agreed with the idea for a police officer being assigned to the adult communities. He would also like to have a contact person to call, in order to introduce the officer to the residents.

Mr. Hobday also commented on the Route 9 area, between Route 88 and the Toms River border. He has received calls about it and asked if there is any news on any proposed improvement projects.

Committeeman Lichtenstein advised that the State has a plan to come through and resurface Route 9 in that area. He contacted the County Engineer and spoke to some of the communities along Route 9, to tell them this is a good time to reach out to the State to say that if the State is coming down with the equipment, don't just come and resurface and repaint the lines; maybe there is some way to maneuver a turning lane down the middle, or do whatever they can do to "ease up" the traffic as it moves north to south. He suggested that Mr. Hobday reach out to the County Engineer with his requests and recommendations.

Mr. Hobday further commented with regard to the defibrillators that have been installed in the Municipal Building.

Dovid Eggert, 1161 Anthony Court – An employee of the Public Works Department, spoke in support of the former Recycling Coordinator, Steven Hill.
