SUMMARY

The following Ordinance of the Township of Lakewood authorizes the sale of Township owned property pursuant to N.J.S.A. 40A:12-1, et seq., known as a portion of Lot 1.04 in Block 830, consisting of approximately 2.91 acres, is irregular in shape, fronts on an unimproved street, is vacant and is located in the R-40C Zone.
