The following Ordinance of the Township of Lakewood authorizes the Township to vacate all of the right, title and interest of and to the public in a portion of Washington Avenue, as further outlined by description contained in the Ordinance, which portion of Washington Avenue is a paper street and remains unimproved, and it has been determined to be unnecessary for public use. This portion of Washington Avenue to be vacated lends itself to higher and better use than for public road purposes and that it is in the best interest of the general public and the Township of Lakewood that the rights and interest in and to this portion of Washington Avenue shall as a public right of way be vacated, released and extinguished.
