

ORDINANCE NO. 2016-11

SUMMARY

The following Ordinance amends Chapter 18 of the Code of the Township of Lakewood, entitled "Unified Development Ordinance", by amending Section 18-200, entitled "Definitions", under Sign Types, to add the definition of "Digital Billboard", as an advertising sign upon which space images are displayed, by means of a digital display of information, provided that a digital billboard may include a static, illuminated, non-digital sign advertising businesses or activities existing at the property on which the digital billboard is situated. The digital billboard may not exceed the length or width or extend more than five (5) feet above the digital billboard. Digital billboards are conditionally permitted in the B-1, B-3, B-4, HD-6, HD-7 and M-1 Zones. This Ordinance further amends Section 18-812.A.12.b., entitled "Prohibited Signs", to provide that Billboards and other signs which advertise, promote, indicate the location of, or otherwise direct attention to a business, product, service or establishment that is not available on the lot upon which the sign is located, except where Digital Billboards are conditionally permitted by this act. This Ordinance also amends Section 18-903.A.5, (B-1 Conditional Uses), Section 18-903.C.2 (B-3 Zone Conditional Uses), Section 18-903.D.2 (B-4 Zone Conditional Uses), Section 18-903.G.2 (HD-6 Zone Conditional Uses), Section 18-903.H.2 (HD-7 Zone Conditional Uses), Section 18-903.M.3 (M-1 Zone Conditional Uses), to add Digital Billboards as a Conditional Use within these zones; and amends Article X (Conditional Use Standards), to add Digital Billboards to provide for Conditional Use Standards, which outlines the permitted uses in the B-1, B-3, B-4, HD-6, HD-7 and M-1 Zones, conditions, and regulations relating to permitted locations, specifications, brightness, application process, and fees.
