RESOLUTION 200601

Resolution of the Lakewood Industrial Commission memorializing LIC action taken on May 13, 2020 to participate in the Township of Lakewood's NJDOT paving grant for 2020 industrial park roadway repaving.

WHEREAS, N.J.S.A. 40:55B-1 et seq., established and described the purposes of an industrial commission; and

WHEREAS, the Lakewood Industrial Commission by virtue of N.J.S.A. 40:55-B-1 et seq., is statutorily charged with, among other duties, promoting the economic well-being, industrial and economic development of the Township; and

WHEREAS, it has been determined that a number of Lakewood industrial park roadways are in need of repair; and

WHEREAS, the Township of Lakewood had been awarded a grant (Grant) for repaving certain roadways within the Township of Lakewood, a list which includes portions Swarthmore Avenue, which is in dire need of repair due to high commercial traffic volume; and

WHEREAS, the Commissioners of the Lakewood Industrial Commission (LIC) are supportive of the program for repair and repaving of aged industrial park roadways to provide safe travel to and from Lakewood industrial park businesses; and

WHEREAS, the Lakewood Industrial Commission wishes to participate in the funding of the repairs/repaying scheduled to be made to industrial park roadways (to induce an increase of the prescribed paying surface funded by the Grant received) in an amount of \$25,000.00; and

WHEREAS, the Lakewood Industrial Commission has adequate funds available from Industrial Commission accounts to reimburse the Township of Lakewood for their financial outlay and participate in this repair program.

NOW, THEREFORE, BE IT RESOLVED, that the Lakewood Industrial Commission shall support the 2020 NJDOT repaying program of portions of Lakewood industrial park roadways and shall provide funding in the amount of \$25,000.00 to the Township of Lakewood in support of their grant participation requirements with the State of New Jersey Department of Transportation.

BE IT FURTHER RESOLVED, that

- The Executive Director be and is hereby authorized to execute any and all documents to facilitate LIC performance in this program.
- Payment will be provided to the Township of Lakewood upon demand.

WHEREAS, Local Public Contracts Law (N.J.S.A. 40A:11-1 et seq) permits the award of a Professional Services Contract without competitive bidding; and

WHEREAS, the Lakewood Industrial Commission (LIC) is the owner of the Strand Theater asset located at 400-410 Clifton Avenue; and

WHEREAS, the Lakewood Industrial Commission deems that property management and maintenance services are required to safely and responsibly maintain this asset in good condition and lawfully; and

WHEREAS, Aggressive Property Maintenance, Inc., 580 Squankum Yellowbrook Road, Farmingdale, NJ 07727 was awarded a two-year contract effective July 1, 2018 for performance of building management and building maintenance services to the Strand Theater asset (which includes the apartments component); and

WHEREAS, as set forth within the contract executed, this contract term may be extended for one additional year; and

WHEREAS, the Lakewood Industrial Commission wishes to take the option to extend the contract for an additional year as referenced within the contract.

WHEREAS, adequate funds are available to fund this contract extension within Industrial Commission accounts established for operations of the Strand Theater asset.

NOW, THEREFORE BE IT RESOLVED that the Lakewood Industrial Commission shall authorize the Executive Director to negotiate and execute any and all documents needed to effect a one-year extension of the existing contract with Aggressive Property Maintenance, Inc. as indicated therein.
