Title: REFUNDING BOND ORDINANCE OF THE TOWNSHIP OF LAKEWOOD, IN THE COUNTY OF OCEAN, NEW JERSEY, PROVIDING FOR THE REFUNDING OF ALL OR A PORTION OF THE TOWNSHIP'S GENERAL IMPROVEMENT BONDS, SERIES 2007, DATED NOVEMBER 1, 2007, APPROPRIATING AN AMOUNT NOT EXCEEDING \$5,500,000 THEREFOR AND AUTHORIZING THE ISSUANCE OF NOT TO EXCEED \$5,500,000 GENERAL OBLIGATION REFUNDING BONDS OF THE TOWNSHIP OF LAKEWOOD FOR FINANCING THE COST THEREOF
