SUMMARY

The improvements authorized by the following Bond Ordinance, and the purposes for which the bonds or notes are to be issued, are various projects for the Lakewood Township Police Department, including, but not limited to, a computer system for scanning and indexing of records, a new Cell Block CCTV System and the installation of a traffic signal at Forest Avenue and 14th Street in the Township, and includes all work and materials necessary therefor and incidental thereto. This Bond Ordinance appropriates \$425,000, and provides for the issuance of \$403,750 in Bonds or Notes to finance the same.
