The following Bond Ordinance of the Township of Lakewood provides for an amendment to Bond Ordinance No. 2003-48, adopted August 7, 2003, amending the purpose set forth in Section 3(f) thereof, in its entirety, to provide for acquisition and improvements for the Department of Public Works, including, but not limited to, replacement of equipment, playground equipment, replacement steps at Town Square, renovations to the Municipal Building, construction of a new Public Works Facility, and Phase 1 and Phase 2 of the Township Vine Avenue Sewer Upgrade Project, comprised of the expansion of the Sewer System at various locations in the Township, including but not limited to Broadway, Argyle Avenue, Halsey Street, Clyde Avenue, Oak Street, Vine Avenue and Spruce Street, including all work and materials necessary therefore or incidental thereto.
