#### **EXECUTIVE DIRECTOR'S REPORT:**

Mr. Corby: I just want to inform everyone that the UEZA approved the (Industrial Park) road improvement project in the amount of \$300,000 +. We are amending the UEZ Project to include the Airport Road portion. Hopefully, we will have the amendment to the original project approved after September; we are pretty much ready to go out to bid for a contract.

#### **ATTORNEY'S REPORT:**

Mr. Delanoy: The only thing I have to report on at this time is an update on the Hamilton Partners closing. I think I told you at the last meeting that we were getting ready for closing and that we were just waiting for a survey from the purchasers to define the metes and bounds of the perimeter of the property. The survey was received yesterday. Unfortunately, the survey that was made was of the entire property and not of the parcel that were actually selling, so now we have to get the survey corrected to reflect the actual metes and bounds. This will slow us down, but not too much. We will push to get this closed by the next meeting in September.

Mr. Albert: How much money are we going to get?

Mr. Corby: This are not the same circumstances we talked about earlier. This is to be

used for parking.

Mr. Golub: Ok.

# **NEW BUSINESS:**

Mr. Corby: Summer meeting schedule ~ you are all aware of this subject. Should the Commission cancel the August meeting or not?

Commissioners, by consensus, agreed to the cancellation of the LIC August meeting scheduled for August 23, 2006.

Mr. Golub: Mr. Corby, will you correspond with Jesel to come in for the September meeting?

Mr. Corby: Yes, and I will respond to the other interested parties with respect to the new value policy adopted.

Mr. Albert: I brought up one subject concerning the Northeast Parkway Acquisition Area whether we would take any steps to obtain access by purchase.

Mr. Corby: I don't think we need it with the Northeast Acquisition Area.

Mr. Albert: That's the wetlands; what we need to get is permission to go across the wetlands.

Mr. Corby: Certainly for Rt. 70 - we will investigate if there is property for sale.

Mr. Golub: I had the opportunity to speak with Ed Bennett Jr. and I found out that a company called White Elephant owned two parcels over there. The developer had asked me if I know anything about the Oak Street Landfill I said yes, and he said, "do you know those folks??" I will ask him if he interested in possibly dealing with the Commission for the purposes of acquiring land for the greater purpose of developing the area.

Mr. Albert: I would suggest that Mr. Corby drop Mr. Bennett a note saying that we would be interested in acquiring property for access.

Mr. Golub: I won't have a problem with that.

Mr. Corby: So that I understand, White Elephant owns another piece of property that could give us access to the Oak Street Landfill?

Mr. Albert: Yes, he owns a number of pieces that surround the dump.

Mr. Golub: We are updating them that we are inviting Jesel to give us a presentation and see what the outcome of that would be.

Mr. Corby: Yes, and also a number of things that I would include in a memo to them.

Mr. Silberberg: Do we want to put this issue to bed with the dollar amount for the property?

Mr. Corby: Yes, what is the melded value?

Mrs. Doyle: The melded value, now that we were looking at a number of them...that large lot at this point... the land value is basically \$119,854. That's the one that Alpha owns and needs the mitigation property...it's 15.1 acres.

Mr. Silberberg: \$120,000 as round number

Mr. Corby: and ours is \$70,000

Mr. Corby: Let's be more specific with respect to this piece of property.

Mr. Silberberg: Everything we have giving you is out of the new revaluation.

Discussion followed with a concurrence that the Commissioners offer this particular property to Mr. Pollack for a melded value of \$120,000.00. It was noted that, in the future, sale prices would be determined on a case by case basis.

Motion by Mr. Golub / Mr. Silberberg to establish the policy of land sale as a melded value within the airport hazard zone for purposes of conservation to be valued at the difference between full value of the property and the access value of the hazard zone area.

Mr. Albert: Mr. Attorney, as much as I'm associated with the airport, can I vote on this?

Mr. Delanoy: Yes, I think you can, I think the issues are not related.

Mr. Albert: Ok
