RESOLUTION

Authorizing creation of the paid position of Career Battalion Fire Chief and establishing duties and compensation for the Board of Fire Commissioners of Fire District No.1, Township of Lakewood, County of Ocean, State of New Jersey.

WHEREAS, the Board of Fire Commissioners of Fire District No. 1, Township of Lakewood, County of Ocean, State of New Jersey, being duly organized under the Laws of the State of New Jersey, is charged to provide prevention and extinguishment of fires and regulation of fire hazards within the Township pursuant to N.J.S.A. 40A:14-81; and

WHEREAS, the Board of Fire Commissioners of Fire District No. 1, Township of Lakewood, County of Ocean, State of New Jersey, finds a need for career Battalion Fire Chiefs (Job Specification Code 00856@) within the District in order to carry out the mandated charges as set forth above; and

WHEREAS, certain duties and functions are required to properly carry out the mandated powers and duties of prevention and extinguishment of fires and regulation of fire hazards; and

WHEREAS, N.J.S.A. 40A:14-81.1 permits the establishment of a paid position within the Fire District and sets forth procedures for establishment of same.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Fire Commissioners of Fire District No. 1, Township of Lakewood, County of Ocean, State of New Jersey, as follows:

1. The position of career Battalion Fire Chief - New Jersey Civil Service Commission (NJCSC) Job Specification Code 00856@ be and the same is hereby established;
2. The compensation and other emoluments attendant to said position shall be established by the Board of Fire Commissioners of Fire District No. 1;
3. The position of career Battalion Fire Chief shall undertake any and all duties established by the Board of Fire Commissioners of Fire District No. 1 and NJCSC Job Specification Code 00856@;
4. The Battalion Fire Chief's shall be under the direct supervision of the Career Fire Chief and Career Deputy Chiefs (should the position of career Deputy Chief be created);
5. The work schedule shall be those hours as deemed necessary by the Board of Fire Commissioners of Fire District No. 1 and pursuant to a Collective Bargaining Agreement.
6. The qualifications for said paid position shall be those as established by the Board of Fire Commissioners of Fire District No. 1, the New Jersey Civil Service Commission (NJCSC) and applicable law including, but not limited to, N.J.S.A. 40A:14-81.2;
7. All other terms and conditions of employment relative to said position shall be established by the Board of Fire Commissioners of Fire District No. 1; and
8. All appointments for said position shall be made in accordance with N.J.S.A. 11A:1 et seq.; and
9. This Resolution is to take effect following the formal adoption, publication and posting pursuant to and in accordance with the New Jersey Title 40A of the New Jersey Statutes, specifically, N.J.S.A. 40A:14-81.1.

NOTICE is hereby given that the above Resolution was introduced and passed upon first reading at a regular meeting of the Board of Fire Commissioners of Fire District No. 1, Township of Lakewood, County of Ocean, State of New Jersey, on June 9th, 2026 and will be considered for final passage at the regular meeting of said Board of Fire Commissioners to be held on July 14, 2026, at 5:30 p.m. at the Office of the Board of Fire Commissioners, 733 Cedar Bridge Avenue, Lakewood, New Jersey, at which time and place any person wishing to be heard shall be given this opportunity.
