## PROPOSED AMENDMENTS TO THE STATE PLAN POLICY MAP Thursday, February 16, 2023 at 5:30 PM

**PLEASE TAKE NOTICE** that the Township Committee of the Township of Lakewood, County of Ocean, State of New Jersey will be holding a public hearing commencing at 5:30 PM on February 16, 2023 to consider three (3) proposed amendments to the State Plan Policy Map in the Township of Lakewood. The areas of the proposed amendments are:

- **1.** Block 549.01, Lot 1 (Portions Located in State Planning Area 2); Block 549.02, Lot 1; Block 554, Lot 1; and adjacent rights-of-way of America Avenue and Drexel Avenue;
- **2.** Block 1160.01, Lots 386 and 387, which comprise an area that is located approximately 350 feet from the southeastern corner of Airport Road and Cedar Bridge Avenue; and,
- **3.** Block 1160.03, Lots 42 and 43, which are located at the southwestern corner of Healthcare Way and Towbin Avenue.

The proposed amendments have been preliminarily included in a required "Biennial Review of the Status of Planning Implementation Agreement Efforts," which was submitted to the New Jersey Office for Planning Advocacy on October 20, 2022 in connection with the Plan Endorsement approved by the State Planning Commission on December 7, 2017.

Public comment is welcome and encouraged at this hearing. The Governing Body will consider potential revisions to the proposed amendments and a resolution approving submission to the State Planning Commission.
